TECHNICAL SPECIFICATIONS:

1. Specification Section 00 11 16 – INVITATION TO BID

Separate sealed bids for the Town of Alberton – Water System Improvements Project will be received by the Town of Alberton (the "Town") Attn: Leslie Hottinger – Town Hall - 607 Railroad Ave, Alberton, MT 59820, until 2:00 p.m. local time on Friday, April 19, Tuesday April 23, 2024, and then publicly opened and read aloud at the Alberton Senior Center at 701 Railroad Ave.

2. Specification Section 33 19 23 – WATER METERS, TRANSMITTERS & READING EQUIP.

2.06 WARRANTY

All solid-state meters shall be supplied with the following *minimum* warranty:

- A. Residential (5/8" thru 1") meters:
 - i. New-meter accuracy (±1.5%) guaranteed for a minimum of twenty (20) years with a minimum of 10 years non-prorated and a maximum purchaser repair/replacement expense of 40%.
 - ii. Structural case integrity guaranteed for a minimum of 20 years non-prorated;
 - iii. Electronics (meter, output encoder, batteries, transducers, LCD) guaranteed for a minimum of 20 years with a minimum of 10 years non-prorated and a maximum purchaser repair/replacement expense of 40 <u>75</u>%;
 - iv. Measuring chambers, solid state measuring elements guaranteed for a minimum of 20 years with a minimum of 10 years non-prorated and a maximum purchaser repair/replacement expense of 40 <u>75</u>%;



PART 3 – EXECUTION

3.01 All meters within residences shall be installed by a certified, licensed plumber in strict compliance with applicable plumbing codes.
